How to send us your forms

This direct debit payment form must be accompanied by all bond lodgement form(s) to which the payment relates.

Direct debit authority ID

A direct debit authority ID is a unique identifier assigned to your Landlord ID. It should be used by you in all correspondence with Tenancy Services relating to direct debit payments. Your direct debit authority ID must be written on any direct debit form, which must accompany a bond lodgement form (or forms) in order to authorise payment.

If you have not been given a direct debit authority ID by Tenancy Services, you must first complete a direct debit authority form.

Dishonoured direct debit payments

Dishonoured payments may be automatically retried within 5 working days (in accordance with the terms and conditions of your direct debit authority).
